SUBMISSION GUIDE

Three complete copies of manuscripts should be sent to the following Business Office of the Journal:

The manuscripts must be typed, double spaced, on one side of 8 1/2 by 11 inch or A4 metric white paper, and its length can not exceed 50 pages.

The first page should include: Title, Author(s) name, and Abstract (not more than 100 words). Affiliation appears in the foot note * of the first page of the text, with a superscript * to the author's name.

The Appendix should appear at the end of the paper, before the references.

Figures should be originals drawn on 8 1/2 by 11 inch or A4 metric heavy white paper with large enough lettering to survive photographic reproduction.

Tables and figures should be on separate sheets and numbered by Arabic numerals. The position of tables and figures should be indicated in the manuscripts.

Footnotes should be numbered consecutively and be double spaced. They may appear at the bottom of each page of the text. Acknowledgments, if any, should be made in footnote 1, with a superscript to the end of the title.

References should be listed alphabetically on a separate sheet at the end of the paper in the following standard form:

Book: Author(s) (year), *Title*, City of Publication, Publisher, Page #s.
Published Article: Author(s) (year), "Title," *Journal*, vol. #, Page #s.
Unpublished Article: Author(s) (year), "Title," type of paper, University or
Foundation, Page #s.
