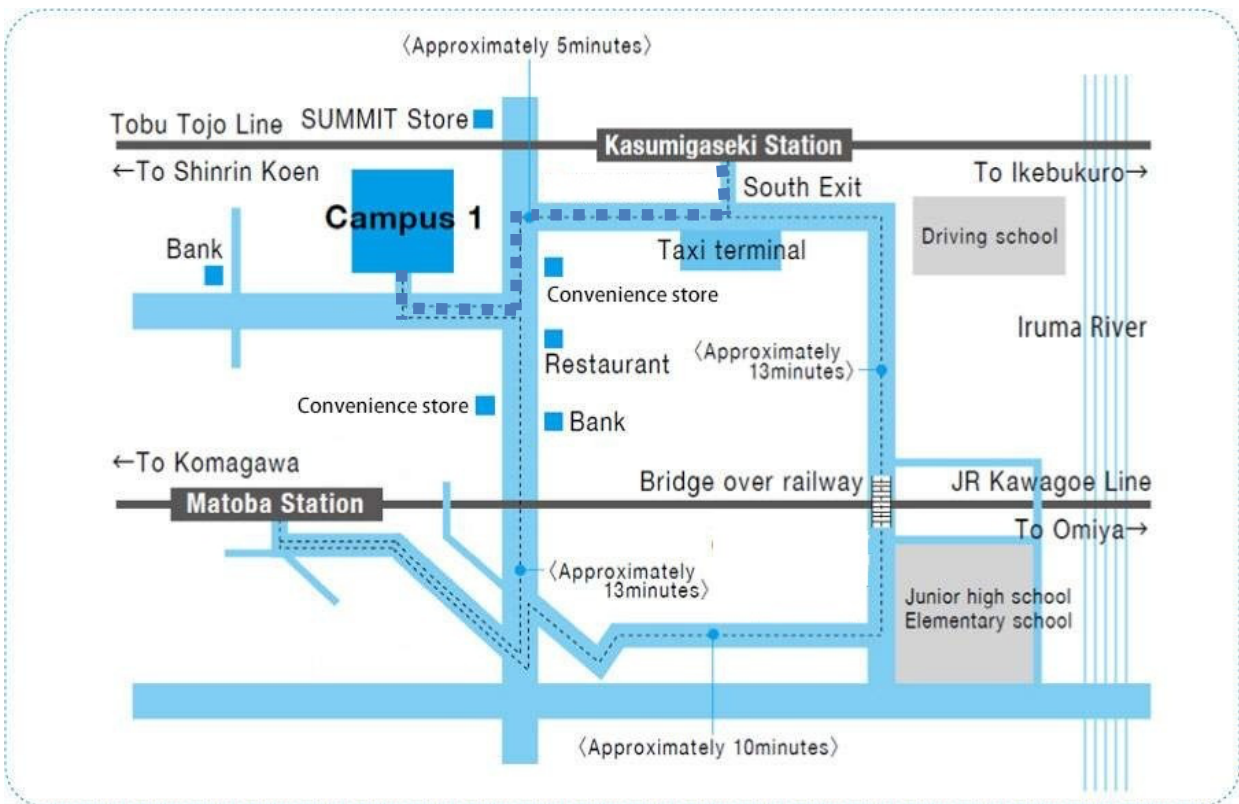

## Area Map

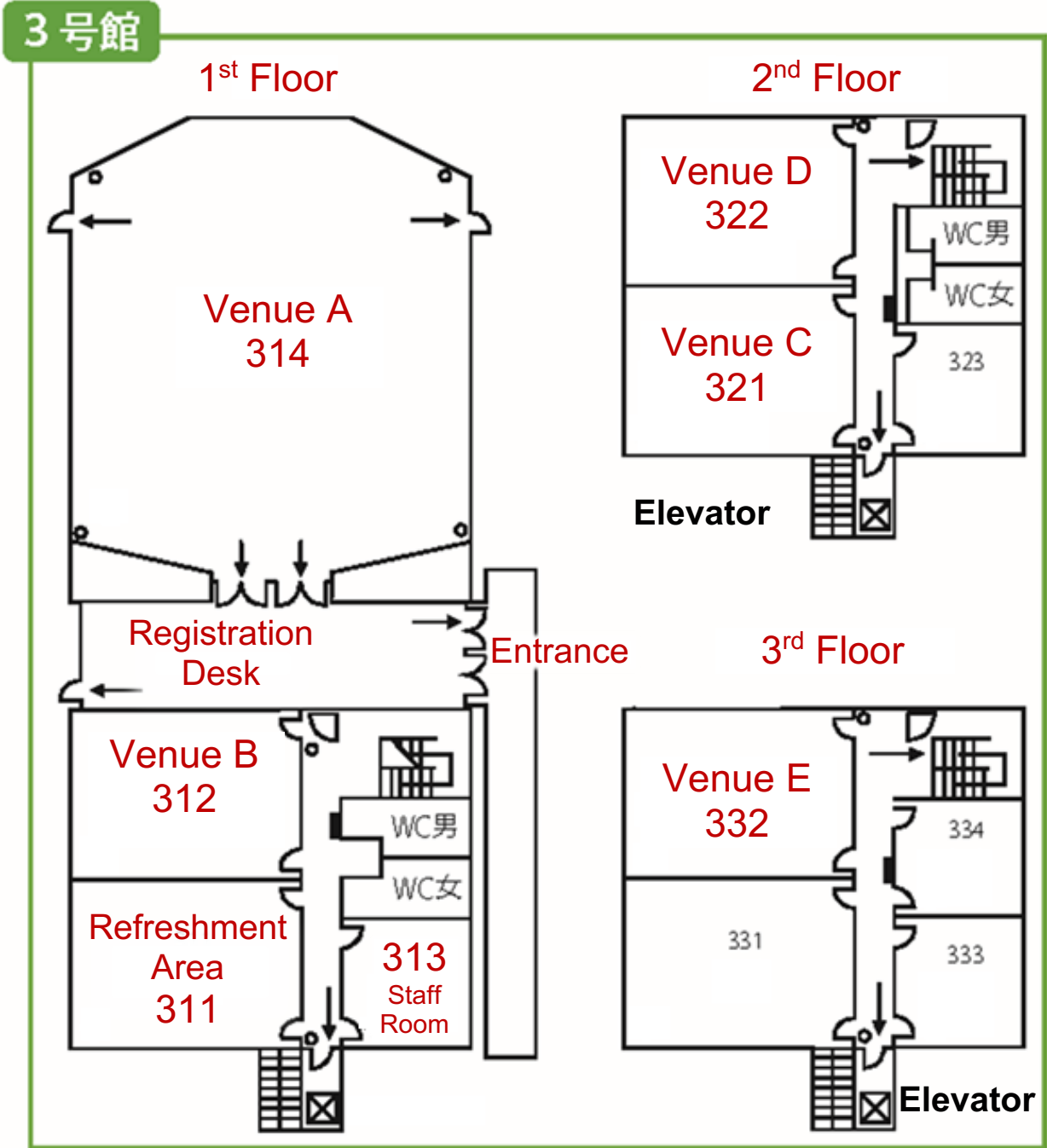


- Tokyo International University, Kawagoe Campus 1**

## **The Keynote Speaker**



### **Jinmyon Lee**

Senior Research Fellow,  
Korea Institute for Industrial Economics & Trade  
(KIET)

Dr. Jinmyon Lee is a Senior Research Fellow at the KIET and a leading expert in industrial economics and input–output analysis. With more than three decades of experience in policy-oriented research and academia, he has conducted extensive empirical studies on industrial structure and economy-wide spillover effects.

His research focuses on the use of input–output tables and multi-regional input–output (MRIO) models to analyze structural change, economic growth, and inter-industry linkages in trade and services. He has made significant contributions to the quantitative evaluation of industrial and macroeconomic policies through analysis of inter-industry and inter-regional linkages.

Dr. Lee has held senior research positions at major Korean policy research institutions, including the Korea Development Institute (KDI) and KIET, and has served as a visiting researcher and visiting professor in Japan and China. He has also played leading roles in academic communities and currently serves as an advisory member of the Input–Output Team at the Bank of Korea, as well as an editorial board member of the *Journal of Economic Structures*.

In his keynote address, Dr. Lee will discuss the evolution, compilation systems, and applications of various types of input–output tables in Korea, and present perspectives on future development directions of Korea’s input–output framework.
